




Fig. 1 - Typical Forward Voltage Drop Characteristics




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 4 - Maximum Thermal Impedance Z_{thJC} Characteristics





Fig. 5 - Maximum Thermal Impedance Z_{thJC} Characteristics (FULL-PAK)





Fig. 11 - Reverse Recovery Parameter Test Circuit



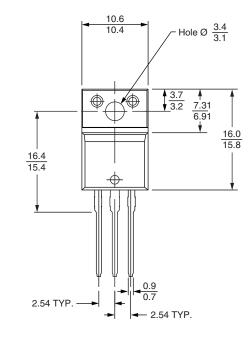

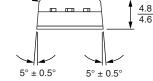

DIMENSIONS in millimeters

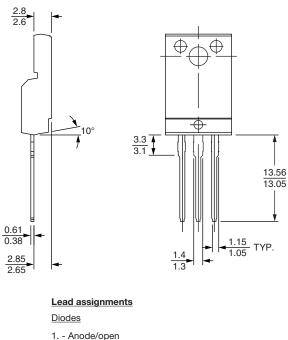
